



M&A Deal of the Year 2022 | Brookfield Acquisition and Privatization of Inter Pipeline





Bill Jenkins, Partner, co-led the Dentons team who advised the Special Committee of the Board of Directors of Inter Pipeline Ltd. in its response to an unsolicited takeover bid by Brookfield Infrastructure Partners L.P. The successful auction process concluded with Brookfield increasing its offer to secure the Board's support for the acquisition at a valuation of approximately CA\$15 billion on an enterprise-value basis. This transaction won the "M&A Deal of the Year" at the 2022 Canadian Law Awards.
