EU: AI Act & AI Liability Directive

The updated Product Liability Directive, harmonizing aspects of liability for damage caused by products, was published in the EU's Official Journal. The definition of "product" newly includes software and—by extension—AI. READ MORE

The EU Commission published the first draft of the General-Purpose AI Code of Practice. The Code is intended to help providers demonstrate their fulfillment of AI Act obligations. READ MORE

The EU Commission (AI Office) held a stakeholders' consultation on guidelines for the definition of an AI system and prohibited AI practices under the AI Act.

Al Guidance and DPA opinions

The Dutch DPA issued final recommendation on supervision of AI, outlining how the use of AI can effectively be supervised through a close collaboration between supervisory authorities. READ MORE

The Information Accountability Foundation provided guidance on the legitimate interest assessment regarding the processing involving an AI. READ MORE

AI Guidance and DPA opinions

A group of academic researchers from KU Leuven and Stanford University published a paper on mitigating systematic risks posed by general-purpose AI. By surveying over 70 experts, the researchers sought to compare available mitigation measures on reliability, feasibility and suitability for specific risks. The findings: safety incident reports, security information sharing, third-party pre-deployment audits and pre-deployment risk assessments are the measures most trusted by AI experts. READ MORE

TEAM NB Association published a Questionnaire on Artificial Intelligence in Medical Devices in order to develop a common guidance for manufacturers. The guidance specifies existing industry standards that may help address specific concerns in medical devices using AI. READ MORE

The Norwegian DPA and Norwegian University of Science and Technology shared their takeaways from the deployment of Microsoft's AI assistant Copilot. The published findings of the regulatory sandbox provide a unique deep dive into the privacy assessments and measures required when implementing the tool. READ MORE

AI-IP related updates

The Spanish Ministry of Culture proposed draft legislation that would allow Collective Management Organizations (CMOs) to grant nonexclusive collective licenses for the mass use of copyrighted works for the development of general-purpose Al.

GEMA—the German musical-industry collecting society—filed a lawsuit against OpenAl with the Munich Regional Court for unlicensed use of protected musical works. The lawsuit marks an important milestone as it is reportedly the first lawsuit brought by a collecting society against a provider of a generative Al system in the EU. READ MORE

Canada's major news publishers filed a lawsuit against OpenAl over misuse of news articles for Al training. The claimants assert that OpenAl trained ChatGPT on proprietary content scraped from their websites without authorization, disregarding license terms and technical restrictive measures.

Eleonora Rosati, a renowned law professor, published a comparative analysis of liability for Algenerated outputs under international, EU and UK copyright law. READ MORE

Tens of thousands of artists, including artists' organizations, released a joint Statement on Al training. **READ MORE**

AI-IP related updates

A group of authors issued a comprehensive comparative legal analysis addressing the copyright aspects of Large Language Models (LLMs) under the laws of the United States, EU, UK, Japan, Singapore and Switzerland. READ MORE

Market updates

The US White House released Framework to Advance Al Governance and Risk Management in National Security. READ MORE

The New AI Transparency Act was adopted in California, USA. With effect from January 1, 2026, providers of generative AI with over 1 million monthly users will be required to boost their transparency measures. READ MORE

The Finnish DPA fined Posti, the country's main postal service, for automatically creating electronic OmaPosti mailboxes without a separate request. READ MORE
