


## **Global Situation Update: April 20, 2021**

### WHAT WE'RE WATCHING

Today is the deadline for the expulsion of the French ambassador to Pakistan set by the Islamist group Tehreek-e-Labbaik. The religious group is behind an anti-France campaign for months since President Macron defended the right of Charlie Hebdo magazine to republish cartoons depicting the Prophet Muhammad.

In response to deadly protests and hostage taking, Pakistani Prime Minister Khan has called on the West to criminalize blasphemy against Islam and also shut down social media in the fifth most populous country on Earth.

# Global


# Globally, confirmed cases of coronavirus rose to 142.0 million with 3.0 million deaths.

- **Global CO2 emissions** from energy are seen rising nearly 5 percent this year, warned the International Energy Agency.
- According to Reporters Without Borders, the coronavirus pandemic has contributed to a "dramatic deterioration" in people's access to information around the globe, helping governments block news coverage and criminalizing reports critical of authorities' response to the crisis.



# Global

Israel is a global vaccine success story with coronavirus infections among those over 60 dropping 77 percent alone in February. Israel has vaccinated over 60 percent of its population and has been reporting less than 200 daily new cases amid a population of 8.6 million. The country has reopened and lifted maskwearing requirements.



# **COVID-19 Vaccine**

Israel has registered 8 cases of a coronavirus variant first identified in India and believes that the Pfizer/BioNTech vaccine is at least partially effective against it, per an Israeli health official.

- A WHO panel recommended that proof of vaccination should not be required for international travel.
- Data from almost 4 million people shows that Russia's Sputnik V vaccine has a 97.6 percent efficacy rate.
- Beijing has started to accept vaccination records from people seeking to enter China who have been vaccinated in the US with COVID-19 shots made by US drug makers.



## Markets & Business


Facing increased activist and investor pressure, Japan's Toyota Motor Corp signaled a shift in its climate change stance, saying it would review its lobbying and be more transparent on what steps it is taking.

- European shares edged down from record highs as sovereign bond yields and rising global COVID-19 cases had investors questioning high equity valuations.
- Asian shares rose on Tuesday, encouraged by strong Chinese data, while the dollar stayed at multiweek lows against other major currencies.
- Nvidia's \$40 billion deal to acquire a chip designer from Softbank is under the scrutiny of a UK government national security review, which is set to deliver a report by midsummer.
- The two heads of **Credit Suisse's** prime brokerage business are departing the company amid continued fallout from losses linked to **Archegos Capital.**

- **IBM** returned to growth in the last quarter, beating Wall Street expectations in a sign of rebounding IT demand.
- **United Airlines** said there is "*strong evidence*" that pent-up air travel demand is set to boost the industry.
- **Coca-Cola** said its March sales rebounded to pre-pandemic levels as more people eat at restaurants again.
- **BMW** bounced back stronger than expected in Q1, largely on the strength of Chinese demand.
- Apple said Monday that it plans to make Parler available through its app store, after removing it in January due to objectionable content.

# Africa

- South African firefighters reported that a wildfire on Table Mountain, near Cape Town, had been largely contained, after destroying several buildings at the University of Cape Town.
- South Sudan was forced to destroy some 60,000 doses of AstraZeneca vaccine that expired before they could be used.
- Former **Malawian** President Mutharika accused the government of using corruption allegations as a pretense to persecute him and steal his funds.
- **Chad's** President Idriss Deby won a sixth term; the US said that rebel fighters were approaching the capital.
- Cape Verde's ruling party retained its majority in parliamentary elections.





# Asia

- The **EU** sanctioned 10 **Myanmar** officials and two military-linked conglomerates over the military junta's violent crackdown on protestors.
- **Philippine** President Duterte said he was prepared to send military ships to the **South China Sea** to stake a claim over disputed oil and mineral resources.
- The **EU** released an interim document vowing to step up its presence in the **Indo-Pacific** but stressed that the move is not "anti-China.
- The **Philippines** will resume giving AstraZeneca vaccines to people under 60.
- India will make all citizens over 18 eligible for the COVID-19 vaccine starting next month.
- Speaking at the annual Boao Forum for Asia, Chinese President Xi called for a rejection of hegemonic
  power structures in global governance and economic decoupling, amid growing tensions between Washington and Beijing over
  a widening range of issues including alleged human rights abuses. Human Rights Watch said Monday that the Chinese
  government's actions in Xinjiang could be considered crimes against humanity.



# Europe

- **British** intelligence warned that more than 10,000 British nationals have been targeted online in the past five years by hostile states such as **China**, trolling professional networking sites to recruit new agents and steal secrets.
- **Russia's** prison service said Monday that it had moved Alexei Navalny to a prison hospital as his condition deteriorates after nearly three weeks on hunger strike.



- Armin Laschet will be the candidate for Germany's Christian Democratic Union to succeed Angela Merkel as chancellor. Germany's financial watchdog filed a criminal complaint against a board member of Deutsche Bank over alleged insider trading of Wirecard shares.
- The EU brokered an agreement to end a political crisis in Georgia, including an agreement for new elections, judicial reforms, and the potential release of an imprisoned opposition politician.
- The EU condemned Russia's decision to expel 20 Czech embassy workers from Moscow in retaliation for the expulsion of 18 Russian diplomats from Prague.
- The **UK** added **India** to its "Red List" of countries with severe inbound travel restrictions due to COVID-19. More than 10 million people in the UK have now received both doses of the vaccine. The UK Office for National Statistics found that employees working from home did almost six hours of unpaid overtime each week. **Greece** has become one of the first EU countries to reopen for leisure travelers, welcoming visitors from 30 countries, including the US. Coronavirus-related deaths in the Ukraine surpassed 40,000.

# Middle East

- A Palestinian electoral commission ruled that most East Jerusalemite Palestinians can vote in upcoming elections; Israel has not clarified its stance on the election.
- The recently appointed head of **Tunisia's** state news agency resigned after weeks of protests from journalists who said his appointment undermined editorial independence.
- Iran and the IAEA began talks to determine the source of unexplained uranium traces found throughout the country in examinations over the last few years.
- **Russian** news reported that Russian forces had hit a militant base in northeast **Syria**, killing 200.
- Iran's state news agency said that Tehran "*always welcome dialogue*" with Saudi Arabia, declining to confirm or deny reports that the two countries held secret talks in early April.
- Lebanon's top Christian cleric called on Hizballah to disarm as a prerequisite for stability. Lebanon's deputy parliament speaker, the number two legislative official, called on the Lebanese Armed Forces to take on the governance of the country to alleviate the current crises.

# Americas

- The World Food Program announced a deal to supply food to **Venezuelan** schools.
- Colombia and Peru have both recorded their worst days yet in terms of number of deaths since the coronavirus pandemic began, 420 and 307 respectively. Colombia has recorded more than 10,000 daily new deaths for the past 15 days.
- Canada's finance minister Freeland delivered the government's first budget since 2019, with C\$101 billion (US\$81 billion) in spending over three years. The budget includes investment of up to C\$30 billion (\$23.9 billion) over five years to set up a national childcare program and help female employment recover from harm done by the pandemic.



# **Americas: US**

- Across the nation, 132.3 million people have received at least one dose of vaccine, representing 39.9 percent of the total population. Everyone in US aged 16 years and above is now eligible for COVID-19 vaccination, per the CDC. The FDA halted the production of Johnson & Johnson vaccines at plant in Baltimore as manufacturing problems are investigated.
- The murder trial of Derek Chauvin went to jury Monday after closing arguments. The case is being closely
  watched across the US as a referendum on the degree to which US police officers will be held accountable for
  killing black Americans. State officials are bracing for potential violence once the verdict is returned.
- New York Governor Cuomo announced plans for further easing of capacity limits at cinemas, museums and large indoor arenas next month. The State Department announced it will elevate its "Do Not Travel" guidance to about 80 percent of countries worldwide, citing "unprecedented risk to travelers" from the COVID-19 pandemic.
- Secretary of State Blinken called for increases in **renewable energy investment** as part of a broader effort to position the US as the global leader on climate policy. Blinken stated the US has fallen behind **China**, which holds nearly a third of the world's renewable energy patents and is the world's largest producer and exporter of solar panels, wind turbines, batteries and electric vehicles.




### **Risks to Recovery: The New COVID-19 Surge in Asia**

While a growing number of vaccinations are beginning show results in mitigating COVID-19 outbreaks in a number of countries, infections elsewhere are surging to new record highs. A number of Asian nations are seeing their worst COVID-19 case rates since the start of the pandemic, which darken the outlook for economic recovery and in the worst cases, threaten hospital capacity. India's record surge in COVID-19 cases is making the country COVID-19's global epicenter, as new daily cases reach into the hundreds of thousands. Across Southeast Asia, a number of nations are struggling with record outbreaks as vaccination campaigns get off to a slow start.

India's record surge of COVID-19 has made it the second hardesthit country in the world, threatened hospital capacity and economic recovery, impacted Indian vaccine exports, and raised new concerns about yet another potentially dangerous variant. Given the country's 1.3 billion population, even though over 100 million vaccine doses have been administered, herd immunity is still a distant prospect. The severity of the new outbreak has raised the urgency of vaccinating Indians, leading the Serum Institute of India to prioritize domestic demand at the price of exports. The Serum Institute, a primary global manufacturer of the AstraZeneca shot, is a key supplier of the COVAX facility, not to mention India's many bilateral deals and vaccine donations, which had been making India a growing force in vaccine diplomacy before the latest wave of cases. In early April, the Institute's chief executive told the AP that exports might be able to resume by June – if India's severe outbreak subsides.





### **Risks to Recovery: The New COVID-19 Surge in Asia**

Beyond the impact on global vaccine supplies, international health experts are increasingly concerned about the possibility of new variants, a factor that further feeds India's domestic need for vaccines. Scientists have detected a new variant in the country, known as B.1.617, which has a double mutation that might indicate increased transmissibility and vaccine resistance - though India's ministry of health has downplayed the variant's role in recent case rates. For now, the WHO is calling B.1.617 a "variant of interest," not yet rising to the "variant of concern" category that a number of other strains fall in, such as the better-known variants discovered in the UK, Brazil and South Africa. Scientists say there is not yet enough data on this variant to call it a "variant of concern," but investigations are underway to assess the impact of the double mutation. Even if B.1.617 does not join the ranks of international "variants of concern," health experts remain worried that a prolonged outbreak in the world's second largest country could allow for further variants to develop. As more information emerges, India faces not only a health threat to its population, but also the possibility of being isolated internationally as countries seek to shut down travel with countries where new variants are prevalent. Such an outcome, as

Brazil is currently experiencing, adds to the economic impact of the new virus restriction measures that are already endangering India's economic recovery.

### **Risks to Recovery: The New COVID-19 Surge in Asia**

In Southeast Asia, a number of other countries are also experiencing severe waves of COVID-19. The Philippines is experiencing the region's worst outbreak, with hospitals exceeding capacity and nearly 1 in 5 tests coming back positive - an indication that the virus is spreading undetected in many areas. Manila and its surrounding provinces are back in enhanced community quarantine (ECG), the country's highest level of lockdown measures. While some numbers show that the restrictions are limiting case numbers, overwhelmed hospitals and sluggish vaccinations are causing continued alarm about the outbreak. On mainland Southeast Asia, Thailand just entered a two-week semi-lockdown in response to a surge in COVID-19 cases concentrated around Bangkok, while the country's vaccination campaign struggles to gain momentum. Last week, both Bangladesh began a one-week lockdown and Cambodia placed restrictions on its capitol in response to cases spiking in both countries. The return of restrictions is threatening economic recovery, particularly in tourism-dependent nations. The IMF downgraded its 2021 growth projections for a handful of Southeast Asian countries last week and expressed major concerns about the surge of COVID-19 cases in India – though the fund remains optimistic about global economic growth and the outlook for the broader Asia-Pacific region.

Further north, Japan is also experiencing another wave of COVID-19 cases, a fact drawing global attention as Tokyo prepares to host the summer Olympics in less than 100 days. Japan's slow vaccine rollout has coincided with a surge of COVID-19 around Tokyo and Osaka, with Osaka reporting record highs in daily case numbers. The government has already instituted "quasi-states of emergency" in Osaka, Tokyo and eight other prefectures, which include limited virus control measures like urging work from home and restricting business hours. However, if such measures continue failing to curb outbreaks, tighter restrictions are on the horizon. Just last week, a senior official again warned that the Olympics could be canceled if the country's COVID-19 situation continues to worsen – a prospect with implications not only for international morale, but also for Japan's economic recovery and the government's political fortunes in an important pre-election period.

As of 2100 hours US EDT on April 19, 2021




## **Confirmed Cases (New)**




