

### WHAT WE'RE WATCHING

The economy of Mozambique has taken a hit after French energy group Total declared "force majeure" on its \$20 billon liquefied natural gas (LNG) project in Cabo Delgado province due to repeated attacks by Islamic State-linked jihadists. The oil firm also withdrew all remaining staff from the area.

The move will result in lost revenue for local and international business with interests in the LNG project stand and the government in Maputo. The Islamist insurgency along the border with Tanzania has displaced over 700,000 and killed almost 3,000 since 2017.







### Global

# Globally, confirmed coronavirus cases surpassed 147.8 million with 3.1 million deaths.

- The pandemic is intensifying around the world, with more new coronavirus cases in the past week than in the first five months of the pandemic, the WHO director general warned.
- Scientists from the Joint Research Center of the European Commission said they have detected a large gap, equal to about what the US emits annually, between the amount of climate-warming emissions that countries report and the amount that independent models say reaches the atmosphere.



### **COVID-19 Vaccine**

The US will share 60 million doses from its stockpile of unused AstraZeneca vaccines with unspecified other countries; 10 million doses will be ready to ship within weeks.

- The EU will sue AstraZeneca over alleged breach of contract for failures to meet supply deadlines;
   AstraZeneca says the case is "without merit."
- The developer of Sputnik V said that it is possible to extend the time between two doses of the vaccine for up to three months.
- Egypt approved the Sinovac vaccine for emergency use.
- Brazilian regulator Anvisa's voted unanimously not to approve the Russian Sputnik V vaccine after technical staff had highlighted "inherent risks" and "serious" defects, citing a lack of information guaranteeing its safety, quality and effectiveness.






### **COVID-19 Vaccine**

### Markets & Business

# At least four Turkish cryptocurrency platforms have gone offline since last week after police began investigating fraud allegations linked to the exchanges.

- European equities hovered near all-time highs and government bonds softened slightly as traders held back, awaiting the conclusion of the US Federal Reserve's latest monthly meeting.
- The Nasdaq closed at a new record on Monday for the first time since February's Treasury market sell-off.
- Bitcoin rose 10 percent Monday after five days of losses on reports that JPMorgan will offer a managed bitcoin fund.
- Interjet became the second Mexican airline to file for bankruptcy during the pandemic.
- Starbucks is expected to report record Q1 profits as vaccinations increased.

- Despite supply disruptions, **Tesla** posted a record quarterly profit; however, investors looked with concern on profit margins in the company's core automotive business, prompting shares to fall in after-market trading.
- Michelin returned to profit in January and February, mostly on the strength of Chinese demand.
- Lyft is selling its self-driving unit to Toyota for \$550 million.
- Novartis missed Q1 expectations as the pandemic hit demand for drugs for breast cancer, skin and eye conditions.



### **Africa**

 Chad's military junta, which assumed power following the death of newly-reelected President Deby, appointed a presidential runner-up and Deby ally as interim prime minister; opposition leaders dismissed the appointment.

Somalian soldiers occupied the capital of Mogadishu, opposing President Roble's
decision to extend his term for two years and calling for a return to stalled negotiations
over rescheduling national elections. The African Union will hold a summit to mediate
the dispute in the coming week.

- Total declared force majeure on its natural gas installation on Mozambique and confirmed that it had withdrawn all staff following the occupation of nearby towns my Islamist militants. The World Food Program is reportedly still unable to access the Palma region.
- Uganda may approach its creditors to suspend debt payments.



## Asia

- Vietnam is tightening COVID-19 prevention efforts ahead of holidays starting
   Friday, as neighboring Cambodia and Laos both experience a rise in cases.
- The **Philippines** surpassed 1 million COVID-19 cases.
- The military confirmed that an Indonesian regional intelligence chief was killed by an ambush in the Papua region; President Widodo vowed Monday that armed groups in Papua would be arrested.
- Key parties in Myanmar's anti-coup resistance movement criticized ASEAN's
  five-point plan, saying it is not in line with the needs of the people. Local media reported that
  Myanmar security forces killed two people and wounded several others on Monday, one day after
  the ASEAN consensus.
- India's government is under fire for a policy change that will force private and public buyers to pay more for vaccines. The Indian government has asked platforms like Twitter to censor content that is critical of official handling of COVID-19. A new US study forecasts that COVID-19 fatalities in India will continue to rise until mid-May, with 200,000 deaths expected in the next three weeks alone. France pledged "substantial medical aid" for India. Malaysia and Thailand will temporarily bar flight from India starting Wednesday and Monday, respectively. Australia also suspected flights from India.



## Europe

- Data from the UK's Office for National Statistics found that education was one of the country's most pandemicresilient sectors, as judged by measures of turnover.
- Germany's Chancellor Merkel pledged that all Germans
  will be eligible for a vaccine by June at the latest and
  reiterated an earlier pledge that all Germans could be
  vaccinated by September. A number of cities in Germany have applied nightly curfews and closed museums
  again amid a continuing rise in cases. A survey of German manufacturing companies found that global supply
- Portugal recorded its first day without any COVID-19 deaths since August. Turkey imposed a "full closure" until May 17. France reopened schools for in-person instruction.



chain disruptions are causing a growing drag on business optimism.

### Middle East

- Saudi forces intercepted and destroyed a remote-controlled booby-trapped boat in the Red Sea near the port of Yanbu,
- Saudi Arabia advised pregnant women that it is safe to receive a COVID-19 vaccine.
- Pakistan surpassed 800,000 confirmed virus cases.
- The EU announced a third round of indirect US-Iran talks on the nuclear deal will commence today.
- In a leaked tape, Iranian Foreign Minister Zarif says the IRGC plays too
  large a role in Iranian foreign policy. Iran sentenced high profile
   British-Iranian detainee Nazanin Zaghari-Ratcliffe to one year in prison and a one-year travel ban.
- Egyptian officials report that the Palestinian Authority plans to call off its first elections in 15 years, citing Israel's refusal to allow voting in east Jerusalem.



### **Americas**

Mexico is waiving an upcoming shipment of COVID-19 vaccines from India in an expression of solidarity. On Sunday, Mexico's foreign minister headed to Russia to discuss plans for Mexico to acquire Sputnik V vaccines.

 The US imposed sanctions on a member of Guatemala's Congress and a former presidential advisor over corruption.

- The **US** unveiled an additional \$310 million in aid to **Central America** to control migration.
- Venezuela's National Assembly is poised to ratify a law that will let the government confidentially sign deals with private firms to shield partners from potential US sanctions.







### **Americas: US**

- Across the nation, 141 million people have received at least one dose of vaccine, representing 42.5 percent of the total population.
- **New York** Governor Cuomo announced that capacity limits on offices, gyms and outdoor events will be further eased in May. In **New Jersey**, indoor gathering capacity will increase to 50 percent, allowing weddings, proms and funeral services; the expansions will not include bars and nightclubs. **California** governor Gavin Newsom will face a recall election this year after opponents gathered enough signatures to trigger the vote; voters are frustrated over the Democrat's handling of the coronavirus pandemic. **Georgia** surpassed 20,000 deaths.
- Top White House economic adviser Brian Deese formally announced the Biden Administration's proposal to nearly double the capital gains tax, arguing that there is no evidence such a tax hike would negatively impact long-term US growth.
- Orders for **durable goods** in the US rebounded in March but by a smaller-than-expected margin, weighed by the global chip shortage and weak demand for commercial airplanes.
- Initial results from the 2020 census show that US population growth slowed to almost its lowest rate in US history, while demographic change will shift political power to more states in the south and mountain west. Changes to house districting is expected to favor Republicans, as more red-leaning states will gain representatives and Republican legislatures have more control over drawing new Congressional maps.
- President Biden spoke with **Indian** Prime Minister Modi Monday to offer US support for India amid India's continuing surge in COVID-19.

### **Key Takeaways from Biden's Climate Summit**

Last Thursday and Friday, President Biden convened a virtual Earth Day climate summit of 40 world leaders, producing a number of significant climate action pledges and introducing the new US administration as a global leader in climate diplomacy. The summit was a key success for the Biden Administration as it seeks to re-establish American credibility on climate issues. For Biden, the summit dovetails with domestic climate efforts in the form of major infrastructure push, which will become a landmark in US climate legislation if passed.

Last week's summit and US efforts to reinforce its climate stance come ahead of a much more important coming climate conference: COP26 (the 26th Conference of Parties), the UN gathering of 197 countries scheduled to take place this November in Glasgow. At COP26, countries will have the chance to update their initial national pledges (officially called nationally determined contributions or NDCs) under the Paris Agreement. The new pledges made last week both preview NDC updates and set a heightened level of expectation for countries to reassess their climate goals in November.

Pledges from major economies drew the most headlines, foremost among them the new US target of reducing emissions by at least 50% by 2030, more than doubling the country's prior Paris

Agreement commitment. Along with the emissions target, Biden announced an international climate finance plan to aid in the global energy transition. Brazil's pledge to end illegal deforestation in Brazil by 2030 and reach carbon neutrality by 2050 also drew global attention, marking a divergence from President Bolsonaro's history of climate-skeptic stances. Japan and Canada also increased their Paris emissions goals, with Japanese Prime Minister Suga raising his country's emissions reduction target to 46% by 2030 (up from 26%) and Canadian Prime Minister Trudeau pledging to cut emissions by 40-45% by 2030 (up from 30%).

Other key pledges came in less concrete forms, in some cases foreshadowing future announcements and in other cases, prompting concerns about credibility.





### **Key Takeaways from Biden's Climate Summit**

South Korea's President Moon promised to end all public financing of overseas coal power plants, and also announced that an increased emissions reduction target would be coming soon from Seoul. Prime Minister Modi of India (the world's third-largest emitter of greenhouse gasses) did not give any specific emissions pledge but announced a new India-US Climate and Clean Energy Agenda Partnership for 2030. Russia's President Putin gave a more nebulous promise to "significantly" reduce emissions and called for global economies to pay more attention to reducing methane emissions. China's President Xi reaffirmed Beijing's targets of reaching peak emissions by 2030 and carbon neutrality by 2050, also promising to "strictly limit" increases in coal production.

While the summit set an overall high bar for climate goals, boosting expectations ahead of COP26, upholding pledges will prove harder than making them. Already, environmentalists are pointing to mismatch between world leader's words and actions – such as the release of budget numbers last Friday showing that President Bolsonaro approved a 24% cut to Brazil's 2021 environmental budget.

Still, pledges made at the climate summit represent a starting point both for national government goals and for the Biden Administration's budding climate diplomacy. After campaigning on climate as a central pillar of foreign policy, the April 22 summit delivered an early success to the Biden Administration's efforts to build international consensus on climate issues.

Beyond pledges, however, the politics of international climate policy are set to get harder and more controversial. Though leaders may be able to rhetorically agree on the needed endgame, the work of reducing emissions and protecting the environment intersects with numerous more contentious issue areas, including industrial policy, intellectual property rights, territorial disputes (such as those surrounding hydroelectric power dams, Indigenous rights and geopolitical soft power. International leaders may seek to deliberately tie even more issues to climate, as was seen at the summit in Mexican President Lopez Obrador's discussion of linking US-Mexico climate cooperation to immigration.





### **Key Takeaways from Biden's Climate Summit**

For US-China climate cooperation, currently a rare bright spot amid contentious bilateral relations, future engagement risks tipping into more controversial territory. Some analysts have expressed hope that climate cooperation could become a new type of "Ping-Pong diplomacy," invoking the Cold War-era example of building common ground to boost hopes that cooperation on a single issue could help the US and China develop a more harmonious working relationship - even amid other serious sources of tension. When US Climate Envoy John Kerry traveled to Shanghai this month, he called for climate to be treated as a "stand-alone" issue. But this may prove impossible. Domestic politics in the US do not favor cooperation with China, and the appointment of Kerry, who is often labeled as Chinafriendly, has caused a number of politicians to cast suspicion that the Biden Administration may give ground on other issues to achieve climate goals with China. Where the US and China can easily agree on areas of mutual interest, a working relationship and even some healthy competition could be developed to the critical benefit of global climate goals. But where more contentious issues arise, the acrimony in broader bilateral relations may taint climate cooperation.




As of 2100 hours US EDT on April 26, 2021






