


# Global Situation Update: March 16, 2021

#### WHAT WE'RE WATCHING

Greece and Turkey will meet today to discuss bilateral relations and issues related to the Mediterranean Sea, such as disputes over continental shelf claims, territorial waters, and airspace. It will be just the second meeting since talks resumed in 2020 after a five-year hiatus.

The consultative talks take place as both countries vie for access to energy resources in the Eastern Med and come a week after Greece participated in a joint naval exercise in the region with Cyprus, Israel and France.







# Global

# Confirmed coronavirus cases globally surpassed 120.1 million, with deaths at 2.6 million.

- The IMF found that big companies have benefited the most from the pandemic, entrenching the market power of big business.
- Gilead Sciences and Merk are teaming up to develop a long-acting HIV treatment that could be taken every few months rather than daily.
- The Vatican declared that the Catholic Church will not bless same-sex marriage but argued that it could still welcome and bless gay people in a note released Monday.

# **COVID-19 Vaccine**

Amid reports that the US was attempting to dissuade Brazil from buying Sputnik V vaccine, Russia protested "politicization" of vaccines.

- Sweden, Germany, Italy, France, Spain, Portugal, the Netherlands, Cyprus and Venezuela joined the list of countries that have suspended use of the Oxford-AstraZeneca vaccine over concerns about adverse effects.
- The European Medicines Agency will meet Thursday to discuss the links between the of AstraZeneca vaccine and blood clots.
- Indonesia will delay the rollout of AstraZeneca vaccines due to the reports from Europe.
- The WHO said no deaths have been "linked conclusively" to any of the COVID-19 vaccines currently in use.

- The head of the Oxford University group that worked with AstraZeneca to develop its vaccine said there is "no signal of a problem" with its shot.
- NIH Director Collins said that the US could approve the AstraZeneca vaccine within a month, despite suspensions in Europe.
- Hong Kong expanded vaccine eligibility amid criticism for the slow pace of the city's rollout.
- **China** will give special "conveniences" to foreigners inoculated with Chinese-made injections when applying for entry into the country.



# **COVID-19 Vaccine**


Globally, 381.34 million have received vaccinations.

# Markets & Business

# The European Central Bank is aiming to stop bond yields from rising before the euro zone economy is ready to digest higher borrowing costs.

- World stocks rose on Tuesday, as investors anticipated the US Federal Reserve and other central banks meeting this week will keep supportive policies in place to help drive a post-pandemic global economic recovery.
- Research from Citi showed that vaccine rollout has boosted value stocks to their best performance in 15 years, compared to shares in growth companies.
- A rally in **junk bonds** is reducing the costs of borrowing for highly indebted companies.
- News Corp Australia struck a deal with Facebook to pay for use of news on its platform, marking a major breakthrough following Australia's new media law.

- Blackston Group and Starwood Capital have agreed to purchase hotel operator Extended Stay America for \$6 billion.
- Confectionery chain **Thorntons** will close all of its UK stores to more to online sales.
- Yogurt maker Danone SA's CEO has stepped down following a clash with activist investors.
- Volkswagen announced that it will invest in six battery factories in Europe, in a sign of the auto industry's accelerating shift to EVs.
- Nokia announced plans to cut up to 10,000 jobs within two years to trim costs and invest more in research capabilities.



# **Africa**

- Sudan formally wrote to the African Union, the UN, the EU, and the US to request mediation for negotiations over the Grand Ethiopian Renaissance Dam between Sudan, Egypt, and Ethiopia.
- Medecins Sans Frontieres reported that 70 percent of health facilities in the war-torn Tlgray region on **Ethiopia** have been looted and 30 percent have been damaged.
- Ugandan opposition political Bobi Wine was briefly arrested during a protest, then released without charge.
- In northern **Nigeria**, 618 schools have temporarily closed following a string of abductions.







# Asia

Myanmar's military junta extended "full martial law" over more parts of Yangon following the intense weekend of protests. An activist group in Myanmar reported that over 180 have died in weeks of protests following the military coup. China called on Myanmar to stop attacks on Chinese factories, marking Beijing's strongest criticism of the junta since February's coup.

Chinese authorities formally arrested Li Qiaochu, a women's rights activist and girlfriend of prominent jailed legal activist Xu Zhiyong, on "subversion" charges; she was initially detained last month after publicizing Xu's account of torture in detention. The Chinese government has reportedly asked Alibaba to jettison its media assets, amid apparent concerns about the firm's sway over domestic public opinion.

• India is home to 35 of the world's 50 most polluted cities, according to IQAir's 2020 World Air Quality Report, which gathered data for 106 countries.



# Europe

- The **EU** launched legal action against the **UK** over its decision to unilaterally ease trading rules for **Northern Ireland**.
- Oslo, **Norway** implemented its strictest restrictions of the pandemic, including closing all middle and high schools. **Turkey** reported the second highest number of new virus cases yesterday (15,503) in Europe, after **Italy**, two weeks after relaxing restrictions. Coronavirus infections are rising exponentially in **Germany**, warned an expert at the Robert Koch Institute for infectious diseases. One in three people in the **UK** has some form of protection from COVID-19, according to Office for National Statistics.
- **Spain's** far-left deputy prime minister Pablo Iglesias is quitting his position to run in Madrid regional elections. Spain is poised to try a 32-hour workweek, which would allow workers to spend less time at the office without any change in pay.
- Elderly and vulnerable Dutch citizens began voting in staggered three-day elections.

# Middle East


• **Iraqi** officials reported that at least 5 rockets hit an Iraqi airbase in the north of the country, with no casualties.

Libya's interim government was sworn in.

 Iran suspended flights to Iraq over the presence of new strains in the country. Iranian authorities charged a French tourist, arrested 10 months ago, with espionage and propaganda.

• The **US** announced that Special Envoy for **Afghanistan** Khalilzad will indeed attend a summit on hosted by **Russia**.

- Oman blocked Clubhouse nationally, raising concerns about freedom of expression in the Gulf.
- Thousands rallied in Idlib, Syria, the last major stronghold of the opposition, to mark ten years since the antigovernment protests that sparked the civil war. A United Nations body working to ensure justice for war crimes
  committed by all sides in Syria has provided information and evidence to 12 national jurisdictions in support of
  trials.







# **Americas**

 Mexico has asked the US to share doses of the AstraZeneca vaccine that it has in stock. Mexico's President Lopez Obrador downplayed concerns about risks from the AstraZeneca jab.

 Brazil President Bolsonaro named Marcelo Queiroga, a cardiologist, as the country's new health minister, becoming the fourth person to hold the job in a year.

- Bolivia's former President Anez began four months of pre-trial detention as investigators probe accusations that she was part of a coup; human rights groups and the Organization of American States (OAS) have condemned the move as a use of the judiciary for political ends.
- Ecuador's main Indigenous advocacy group urged supporters to spoil their ballots in the country's April 11 presidential elections, after Indigenous candidate Yaku Perez's request for a recount of primary results was denied.



# **Americas: US**

 Nationally, 71.1 million people (21.4 percent of the total population) have received one or more vaccine doses. A CDC study found that 12 percent of Americans did not receive their second dose within the recommended period.

• Mississippi and District of Columbia, which have had some of the slowest vaccine rollouts in the country, announced plans to expand vaccine eligibility. Connecticut and Kansas will also accelerate eligibility timelines. Pennsylvania will loosen coronavirus restrictions next week. In-person school resumes this week for many children in Maryland and Virginia.

- A spring breaks begin, the TSA said about 2.57 million passengers passed through airports this weekend; Friday was the single **biggest day for travel** since March 15, 2020.
- Federal prosecutors charged two men for assaulting Capitol Police Officer Brian Sicknick with a chemical during the January 6 riot.
- The Senate confirmed Deb Haaland as Secretary of the Interior; she will be the first person
  of Native American descent to serve in the Cabinet.



#### Prospects for US-Japan Leadership in the Indo-Pacific

Secretary of State Antony Blinken and Secretary of Defense Lloyd Austin embarked on their first overseas trip of the Biden Administration yesterday, with Tokyo as their first destination. Following "two plus two" diplomatic and security talks with their Japanese counterparts, Austin and Blinken will fly to Seoul to continue highlighting the importance of Indo-Pacific alliances.

The visits follow last Friday's first ever head-of-state-level meeting of the Quad (the strategic forum of Japan, the US, India, and Australia) and comes ahead of an expected early April US visit by Japan's Prime Minister Yoshihide Suga, who would become the first foreign head of state to be hosted by the Biden White House. All this high-level diplomatic activity sends a clear message that the Biden Administration views Japan as key to its Indo-Pacific strategy. But while the US and Japan have many shared strategic interests, obstacles to deepening ties remain, including domestic politics that are likely to keep Prime Minister Suga busy at home for months to come.

#### The Quad and US-Japan mismatch on China

The first Quad leadership meeting last week provided an important glimpse into how the forum may translate talk of shared interests into action in the region, namely through its announcement of a vaccine drive for Southeast Asia. However, it remains unclear how the Quad will coordinate action on China – a question that also remains uncertain in US-Japan bilateral relations. Born as an initiative of then-Japanese Prime Minister Shinzo Abe in 2007, the US and Japan can be seen as the driving forces behind bringing the Quad countries together, but the two countries are not synchronized on the key issue of China policy. Ahead of their first meeting, the Quad leaders published an op-ed in the Washington Post, describing the Quad as "a flexible group of like-minded partners dedicated to advancing a common vision and to ensuring peace and prosperity." The article went on to emphasize cooperation on climate and COVID-19, as well as the four countries "shared vision for an Indo-Pacific region that is free, open, resilient and inclusive," but did not mention China once.





#### Prospects for US-Japan Leadership in the Indo-Pacific

In contrast, a Washington Post op-ed by Blinken and Austin ahead of their first travel painted a picture of Asia at an inflection point, with democracy under pressure from an authoritarian China. One interpretation of the Quad's decision to skirt China issues could be that the Quad has chosen to start with easier, positive forms of cooperation, creating a partnership structure which can counterbalance China but will not yet seek to address China directly. This may be good strategy to create the foundations for a new coalition, but it leaves many thornier foreign policy questions unanswered. Along with deepening bilateral economic and security ties with its Indo-Pacific allies, the Biden Administration is likely to push for its partners to be more active on challenging issues like calling out human rights abuses in China and supporting democracy in Southeast Asia. While the US, Australia, Canada, the UK, and sometimes EU countries have frequently coordinated joint statements condemning Beijing's actions, the Japanese government, which must balance deeper economic reliance on China, has been less vocal on issues like the crackdown on Hong Kong's democracy. In the future, whether Japan joins more US joint statements on China, or in the longer-term, whether Japan starts coordinating with

US sanctions on Chinese officials, will indicate the strength of US-Japan cooperation on China. Myanmar may also prove a test for joint action, as Japan, which did not join international sanctions in the 1990s and 2000s, has more negotiating leverage with the military junta than many western powers, making Tokyo a potential key player in international support for Burmese democracy.

#### Prime Minister Suga's domestic priorities

Another key hurdle to deepening US-Japan relations is the pressing domestic priorities that both countries face, particularly Japan, which is dealing with the COVID-19 pandemic while planning for the Tokyo Olympics and an election year. Prime Minister Suga, who this week marked six months in office, has six more months to go before a September leadership election in the LDP (Liberal Democratic Party) could end his tenure as prime minister. In order to maintain his position, Suga will need strong levels of public support. As Suga is not backed by a particular LDP faction, and because elections for Japan's House of Representatives are currently scheduled for late October, he is unlikely to be re-elected if his popularity remains low.




#### Prospects for US-Japan Leadership in the Indo-Pacific

According to a February Nikkei poll, Suga's approval rating is at 44 percent, marking a decrease from his initial popularity as his government has faced public backlash for its handling of the COVID-19 pandemic and for a number of dining scandals (in breach of COVID-19 guidelines). Some see the summer Olympics, scheduled to begin on July 23, as a make-or-break political issue for the Suga Administration, and some have even speculated that Suga might call snap elections before they begin. In his short time as Prime Minister, Suga has yet to establish himself as a strong presence in international relations, in contrast to his predecessor Shinzo Abe. With six months of high-stakes domestic challenges ahead of him, answering the difficult questions in US-Japan relations is unlikely to be high on Suga's agenda.


As of 2100 hours US EDT on March 15, 2021






