

## Global

# Confirmed coronavirus cases globally surpassed 114.8 million, with deaths at 2.5 million.

- Microsoft said a Chinese-linked hacker group has been targeting email inboxes using a newly discovered flaw in Microsoft's mail server software.
- Three-quarters of the people around the globe live in countries where **freedom** is declining, according to annual report produced by Freedom House.
- More than 168 million children around the world have missed school for nearly a year due to COVID-19 restrictions, per UNICEF, calling the impact of the lockdowns a "*catastrophic education emergency*." The majority of those affected were in Latin America and the Caribbean.



## **COVID-19 Vaccine**

# The US Chamber of Commerce voiced support for a WTO intellectual property rights waiver aimed at speeding global vaccination efforts.

- Merck will help Johnson & Johnson manufacture its vaccine, boosting supply. The US Conference of Catholic Bishops urged Catholics to avoid taking the Johnson & Johnson coronavirus vaccine because it used cells derived decades ago from an abortion.
- The **Covax facility** will supply 237 million doses to 142 countries by May, per an updated report.
- The US is working with Japan, India and Australia (the Quad) to develop a **plan to distribute vaccines** to countries in Asia as part of a broader strategy to counter China's influence.
- **Saudi Arabia** will make a COVID-19 vaccine a prerequisite for Hajj.

- South Korean is investigating the deaths of two people, both with pre-existing conditions, who died within days of receiving AstraZeneca's vaccine. Hong Kong is also investigation the death of a chronically ill individual who died two days after receiving the Chinese-produced Sinovac coronavirus vaccine.
- **France** recommended that people who have already recovered from Covid-19 receive a single vaccine dose, becoming the first country to issue such advice.
- **Brazil's** Congress approved a bill allowing private companies to buy COVID-19 vaccines in an attempt to accelerate the vaccination process.

## **COVID-19 Vaccine**

Globally, 268.57 million have received vaccinations.

Africa, with 4.09 million vaccine doses administered, trails behind all other regions in starting vaccination programs. In a hopeful comment, a senior WHO official said all countries should be able to start vaccinating this month, if pharmaceutical companies step up.

## Markets & Business

Global shares gained on Wednesday, with European markets following the upward trend in Asia, as a retreat in US Treasury yields fueled demand for riskier assets and weakened the dollar.

- President Biden's SEC chairman nominee Gensler pledged to **review market structure** in the aftermath of the GameStop turmoil.
- **Fidelity Investments** saw record profits in 2020, with retail accounts rising 17 percent to 26 million.
- Deloitte PLT will pay the Malaysian government \$80 million to resolve all claims related to their inaccurate audit of 1MDB and its unit SRC International from 2011 to 2014.
- Germany's financial watchdog has taken oversight duties over Greensill Bank, as its parent company warns of insolvency risk that could cause defaults and cost 50,000 jobs.
- **Hertz** proposed a bankruptcy exit by mid-year under the control of a new investor group.
- **Target's** revenue jumped 20 percent last year, with many of its sales gains coming at the expense of its rivals.
- **Thai Airways** announced it will severely downsize operations, cutting its workforce by 50 percent.

## Africa

- A new Amnesty International report accuses all sides government forces, armed militant groups, and military contractors – of committing war crimes in the ongoing conflict in **Mozambique's** Cabo Delgado region.
- France's foreign minister called on Chad to open an independent investigation after at least two people were killed during an operation to arrest opposition candidate Yaya Dillo on Sunday.
- The World Bank is preparing emergency financing to help about 30 African countries access COVID-19 vaccines, including the Democratic Republic of Congo, Ethiopia, Niger, Mozambique, Tunisia, eSwatini, Rwanda and Senegal.





## Asia

- Japan is considering a two-week extension of a state of emergency in the Tokyo area due to continuing high numbers of coronavirus cases.
- Malaysia announced that a number of provinces will exit the country's coronavirus Movement Control Order (MCO) at the end of the week.
- China has surpassed the US as home to the highest number of dollar-denominated billionaires, per the Hurun Global Rich List. China's chief banking regulator warned about risk from a possible bubble in real-estate prices and said that global financial markets are out of step with the real economy.
- Myanmar security forces fired on protests killing nine people, a day after ASEAN foreign ministers
  urged the leaders of Myanmar's military to end violence against protestors and work towards national reconciliation.
   Former UN investigator and expert on Myanmar, called on foreign firms to suspend all business in Myanmar to send a clear
  message to the military that its coup will hurt its people and ruin its economy.



## Europe

- European Commission guidance released today is set to signal that the EU will extend its suspension of budget rules in the face of continuing economic troubles. Spanish unemployment hit 4 million for the first time as German consumption slumped, pointing to a possible double-dip eurozone recession.
- Russia's Ministry of Foreign Affairs called new sanctions imposed by the US and EU were evidence of a "hostile anti-Russian lunge" and said it would retaliate to what it described as another blow to US-Russia ties. The US and EU imposed coordinated sanctions on Russian officials over the attempted poisoning and arrest of Alexei Navalny.
- **Turkish** President Erdogan announced a new "*human rights action plan*," seen as a renewed effort ease tensions with western allies and meet EU membership criteria.
- The **Dutch** government postponed a trade mission to **Qatar**, citing concern over the living conditions of migrant workers.
- Austria and Denmark will partner with Israel to create new vaccines for coronavirus variants. An explosive was detonated at a coronavirus testing centre near Amsterdam before sunrise causing no injuries in what police called an intentional attack; this is the second time a testing facility has been attacked in the Netherlands. Northern Ireland announced a plan to gradually ease coronavirus restrictions. German Chancellor Merkel is expected to agree a gradual relaxation of coronavirus curbs with regional leaders in a meeting today.

## Middle East

- The US sanctioned two leaders of the Yemeni Houthis over attacks on Saudi Arabia, weeks after reversing the blanket terrorist designation of the Houthis over terrorist concerns. A Houthi missile injured 5 in the Saudi Jazan region.
- The **Lebanese** pound hit an all-time low against the US dollar on Tuesday, prompting renewed protests over the country's ongoing economic crisis.
- Over 2,000 Algerians defied coronavirus curfew to participate in anti-government, pro-democracy protests.
- At least 10 rockets landed on Wednesday at Iraq's Ain al-Asad air base, where US, coalition and Iraqi forces are based. No fatalities were reported. It was the second rocket attack in Iraq this month. Pope Francis confirmed he is going to Iraq, where his predecessor John Paul was not allowed to go in 2000, because "the people cannot be let down for a second time."
- Kuwait's emir approved a new cabinet; the previous government was acting in a caretaker capacity
   after resigning en masse after a standoff with parliament. Saudi Arabia said relations with the US will not be hurt by the Biden administration's release
   of a US intelligence report incriminating the Saudi crown prince in the killing of journalist Jamal Khashoggi; the Kingdom has denied the report findings.
- French President Macron told Iranian President Rouhani that Tehran must make clear and immediate gestures to allow dialogue to resume on the 2015
  JCPOA nuclear deal. Israel's defense minister intends to develop a "special security arrangement" with new Gulf Arab allies, who share common
  concerns about Iran.

## Americas

- **Canadian** economic activity grew faster than expected at the end of 2020, despite a resurgence of COVID-19. Brazil's economy minister said the country's economy may have shrunk by less than 4 percent in 2020.
- **Mexican** President Lopez Obrador said that he and President Biden exchanged invitations to visit each other's countries, and that a \$4 billion US aid commitment to help development in Central American will include help for Southern Mexico. Mexico's Senate approved an electricity reform bill opposed by business and is expected to trigger a flood of lawsuits.
- Officials from **Peru and C**olombia said both governments are considering centralizing gold purchases in an effort to prevent illegal extraction.
- Court testimony revealed that **Venezuelan** intelligence services monitored six Citgo Petroleum executives on US soil, leading to their 2017 arrests in Venezuela.
- **Cuba** is starting final-stage trials of two new Covid-19 vaccines developed in the country, Soberana 2 and Abdala.

## **Americas: US**

- President Biden said he expects the US will have enough vaccines for all adults by the end of May. The White House announced another boost in the weekly number of vaccine doses sent to states. Nationally, 51.8 million people (15.6 percent of the total population) have received one or more vaccine doses. The US has delivered more than 100 million doses of vaccine. The FDA has approved emergency use for a COVID-19 antigen test that can be performed at home.
- Texas lifted its statewide mask mandate and allowed all businesses to reopen, making it the largest state to do so.
   Iowa and Montana have also lifted mask requirements. Mississippi also eliminated mask requirements and limits on business capacity. Michigan increased dining and retail capacity and the resumption of small indoor gatherings. In California, San Francisco will resume indoor dining and some cultural activities.
- The Senate confirmed Gina Raimondo as Secretary of Commerce. President Biden withdrew Neera Tanden's nomination as White House budget director. At a Senate Judiciary Committee Hearing, FBI Director Wray warned that the January 6 capitol riots has been an "inspiration" to domestic and foreign extremists.
- Three House Democrats introduced a wide-ranging climate bill that promotes efforts to decarbonize the electric grid by 2035
- The US Commerce Department on Tuesday issued final anti-dumping duties on common alloy aluminum sheet from 18 countries investigated, including Bahrain, Brazil, Croatia, Egypt, Germany, Greece, India, Indonesia, Italy, Oman, Romania, Serbia, Slovenia, South Africa, South Korea, Spain, Taiwan and Turkey.

### **Emerging & Existing Hotspots: US-Iran Relations**

The security situation in the Persian Gulf and greater Middle East is entering a period of higher risk, as tensions between the US and Iran continue to escalate. Over the past week, both Washington and Tehran have engaged in a "tit-for-tat" strategic battle in what is the first real foreign policy test for the new US Administration.

President Biden's decision to order a retaliatory strike against Iranian-backed militias in eastern Syria last Thursday was quickly followed by Iran's rejection of informal diplomatic talks to reestablish compliance with the Joint Comprehensive Plan of Action (JCPOA), the 2015 multilateral accord limiting Tehran's nuclear activities. Compounding these difficulties is the Iranian legislature's decision to limit the scope of ongoing International Atomic Energy Agency (IAEA) inspections, a move that has thrown the future of international diplomatic discussions further into doubt. Although a hastily-agreed compromise was reached between the UN and Tehran, it appears that hardliners in Iran are eager to "*salt the diplomatic earth*" as much as is possible in advance of any potential negotiations with Brussels and Washington. This was confirmed over the past weekend, when Iran rejected an invitation to informal diplomatic discussions with the US to be moderated by the EU.

The US now finds itself in a holding pattern as it relates to Iran policy and achieving its strategic aims in reviving the JCPOA. Administration officials have described last Thursday's strike against Iran-backed militias as intended to be "*non-escalatory*," "*purposefully restrained*," and proportional in order to send a message to Tehran that attacks on US regional interests will not be tolerated. It remains to be seen whether Iran, via its proxies in Iraq and Syria, will continue to test the Biden Administration's boundaries in the upcoming days and weeks. A potential mitigating factor for President Biden's national security team will be the extent to which Iran, publically and privately, denies responsibility for the actions of its proxies, as it did in the most recent attack on a US base in Iraq. Some Iranian officials expressed surprise that Washington retaliated

against a specific militia which had denied responsibility for the attack.

Nevertheless, it appears that the Biden Administration, for the time being, is comfortable with keeping the ball in Iran's court from both a diplomatic and military-security point of view. US officials have confirmed that the offer to restart informal talks with the EU remains valid, while emphasizing that the strike on Iranian-backed militias in Syria has sent a message of strength and deterrence. How Iran responds next will determine the course of Washington-Tehran relations over the next several months.

There are several additional factors that will affect Middle East stability in the short to medium term. The first is the actions of US regional allies in responding to Iranian aggression. On Monday, Prime Minister Netanyahu accused Iran of recent attacks on Israeliowned cargo ships, stating that he is "*determined to halt [the attacks]*" and will be responding accordingly in the near future. A key question is the extent to which Israel will seek to coordinate responses with the United States, and whether the Biden Administration will be eager to go along - reports are already emerging of retaliatory Israeli missile strikes around Damascus. The

same is true of Saudi Arabia, which remains vulnerable to attacks on its energy infrastructure from Iranian proxies in Yemen, Iraq, and Syria. Despite a fraying of relations as a result of the Khashoggi affair, the US has reaffirmed its intention to help defend the Saudi Arabia's territorial integrity - this will be put to the test when and if Iran or its proxies conduct a major attack on the Kingdom. The question remains whether Riyadh or Jerusalem will act independently of President Biden in either responding to attacks or proactively seeking deterrence - it is unclear whether the new Administration will sanction or support the same types of military activities that the Trump Administration endorsed, such as the assassination of a top Iranian nuclear scientist last November.

Finally, it is likely that the Iranian presidential elections in June will act as a political constraint on diplomatic overtures from both Washington and Tehran. Although it is true that top Iranian political leadership (including the Supreme Leader) has committed to the broader strategic goal of re-entering the JCPOA, the contours of how this would be achieved will be affected by who wins the Iranian presidency in several months. At the moment, it appears likely that a hardline candidate will replace the relatively moderate Hassan

Rouhani, meaning that both Washington and Tehran will take harder positions if and when they get to the negotiating table. Iranian calculations may already be that re-entering the JPCOA prior to June is not in anyone's political interest, even if the same is not true for the country's dire economic situation. Regardless of what Tehran does between now and after their presidential elections, the Biden Administration has decided to pursue a course of "*strategic patience*" in re-engaging with Iran. This does not mean, however, that the risks of military escalation are low, as both Iran and the US's European partners now understand that Washington will defend its interests in the region with military force if necessary.




### **Confirmed Cases (New)**




