Global Situation Update: May 18, 2021

WHAT WE'RE WATCHING

Today, French President Macron will host day two of the Summit for the Financing of African Economies with dozens of African leaders. The agenda in Paris is topped by economic recovery from the COVID pandemic, which created a \$300 billion a financing shortfall on the continent.

The in-person top-level conference saw France grant a \$1.5 billion bridge loan yesterday to clear Sudan's arrears to the IMF. The summit also signifies that France wishes to expand its influence beyond Francophone countries to include Ethiopia, Kenya, Nigeria and South Africa.







Global

Confirmed coronavirus infections topped 163.5 million with more than 3.3 million deaths.

- The World Economic Forum has abandoned plans for an in-person annual meeting in Singapore this August as the city imposed new restrictions due to COVID-19 outbreaks in Asia.
- An antiviral drug being studied by scientists at the Menzies
 Health Institute Queensland at Griffith University and US
 research facility City of Hope has been found to reduce the
 amount of coronavirus in the lungs of mice by 99.9 percent.
- A major Japanese doctors' group is calling for the Tokyo Olympics to be canceled over fears that the country's health-care system cannot accommodate the potential medical needs of thousands of international athletes, coaches and media amid a surge of coronavirus cases in the country.

- The Arctic Council will convene this week, with Russia taking the Council's rotating leadership from Iceland until 2023. Other nations on the Council are Canada, Sweden, Finland, Norway and Denmark, with indigenous populations also represented. Climate change will be high on the agenda.
- The window of opportunity for reaching net zero emissions by mid-century is narrowing unless the world radically changes the way energy is produced, used and transported, per the International Energy Agency.



COVID-19 Vaccine

WHO head Ghebreyesus called on vaccine makers to advance doses to the Covax facility to make up for shortfalls from Indian producers.

- US President Biden announced plans to export an additional 20 million doses of approved COVID-19 vaccine by the end of June, in addition to the previously announced 60 million doses of AstraZeneca vaccines.
- The European Medicines Agency approved changes to vaccine storage requirements for the Pfizer shot, allowing for more flexible conditions that will ease vaccine rollout.
- India has found 26 suspected cases of bleeding and blood clotting among recipients of the AstraZeneca vaccine; the health ministry described the risk as "miniscule."



Markets & Business

Hong Kong Disneyland reported a record loss of \$342 million for fiscal year 2020.

- Chocolatier Godiva has pulled back from expanding its own shops to focus on selling chocolates at grocery stores and other retailers as the pandemic changed chocolate-consuming behavior.
- Target and CVS will allow fully vaccinated customers into their US stores without masks, per local law requirements.

- Activist investor Elliot Management is urging Duke
 Energy to consider separation into three companies.
- Parler named prominent British conservative George Farmer, husband of conservative writer Candace Owens, as its new CEO as the app returns to Apple's store.




Africa

 Algeria will begin permitting commercial flights and non-essential border crossings next month.

 The Ethiopian Human Rights Commission and the UN announced a joint human rights inquiry into the conflict in Tigray. Service to social media platforms in Ethiopia were restored after being restricted on Monday, per an internet watchdog.

 Namibia and Germany are reportedly close to an agreement on reparations for an early 1900s massacre of indigenous Namibians by German soldiers.

An expert council appointed by the **Tanzanian** president found the COVID-19 vaccines
to be safe and effective and recommended joining COVAX to receive them, in another
sign that the new president is reversing the COVID-19 skepticism of her predecessor.



Asia

 Tropical Cyclone Tauktae moved ashore in India Monday, bringing high winds, a storm surge and rises of inland flooding that could extend for hundreds of miles.


 Mass vaccination sites in Tokyo and Osaka saw a rush of online bookings after appointments opened; while mass sites aim to accelerate Japan's vaccine rollout, they have faced glitches.

 Taiwan reported 333 domestic cases amid tough new restrictions that have been opposed in Taipei for the first time in the pandemic; Taiwan's schools will close for two weeks.

Thailand reported a record 9,635 cases, 6835 of which were found in prisons across the country.

India reported its lowest daily case rise in over a month, of 263,045 new infections, but a record daily death toll of 4,340, as the country surpassed 25 million infections.

- Indonesia is setting up roadblocks to screen travelers returning from Ramadan gatherings for COVID-19.
- Malaysia is setting up field ICUs to handle overflow of COVID-19 patients.
- The **UK**, **US** and **Canada** imposed new sanctions on the military junta in **Myanmar**. H&M began placing orders with suppliers in Myanmar following a couprelated pause in February. More than 800 people have been killed by Myanmar's security forces since a wave of protests broke out across the country.



Europe

- **UK** Health Secretary Hancock warned that early evidence suggests the new Indian variant B.1.617.2 is "more transmissible" than the UK variant B.1.1.7 but does not seem to be impacting vaccinated people. A group of scientists writing in the British Medical Journal Monday said that new variants mean the UK government should wait a few more weeks before allowing groups to mingle inside.
- The EU agreed to postpone plans to raise tariffs on a series of US goods including whiskeys, motorcycles and boats as it entered talks with the Biden Administration over US steel tariffs.
- The Italian government approved a measure shortening COVID-19 curfews and easing other restrictions.



Middle East

• France promised to lend \$1.5 billion to Sudan and called for further donations at an international conference intended to aid Sudan in clearing \$60 billion in debt.

Violence continued in Gaza and Israel, with the Palestinian death toll surpassing 212. The UN General Assembly will meet Thursday to discuss the conflict. Jordan's parliament unanimously approved a measure calling for the expulsion of the Israeli ambassador to Amman. Kuwait summoned the Czech ambassador after he posted on social media in support of Israel. The UAE's Etihad airline suspended flights to Israel over security risks. US President Biden and Senate Majority Leader Schumer (D-NY) called for a ceasefire in Gaza.

• The Israeli military reported that several shells had been fired from Lebanon towards Israel but fell short of the border.



Americas

• **Brazil's** Butantan Institute halted production of Sinovac's CoronaVac for the first time due to delays in **Chinese** shipments of key vaccine ingredients. Officials have said that Chinese-made supplies for 25 million vaccines should arrive in Brazil in coming days.

- Chilean women secured so many votes in elections for the commission to rewrite
 the constitution that for the first time, election adjustments to ensure gender
 equality had to be made in favor of men; the special assembly selected is
 considered left-leaning and is expected to increase social spending.
- Bolivian authorities reported that they had struck a blow against cocaine producers, finding and destroying three "mega factories."



Americas: US

- Across the nation, 157.8 million people have received at least one dose of vaccine, representing
 47.5 percent of the total population. California will hold off on adopting the CDC's new guidance on
 mask usage for fully vaccinated people until July 15, in order to give businesses more time to adjust and
 people more time to get vaccines. New Jersey will lift its mask mandate for public outdoor spaces
 immediately. New York will adopt the new mask guidance starting May 19. The New York City Marathon will
 resume this year at 60 percent capacity.
- National data is showing that while hospitals are seeing fewer overall **COVID-19 patients**, an increasing proportion of them are under the age of 50.
- Elon Musk impersonators have stolen over \$2 million from US consumers in **cryptocurrency scams** in a "*huge spike*" of such fraud, per new data from the Federal Trade Commission.
- **US gas prices** are at a 7-year high despite the resolution of the Colonial Pipeline closure. The Biden administration announced **new efficiency standards** for federal buildings and speeding up adoption of technologies to heat buildings with electricity rather than fossil fuels.
- The Supreme Court said it will consider the legality of a Mississippi abortion law that will give the court its first chance to
 revisit Roe v. Wade for the first time since Justice Amy Coney Barret was confirmed. On Monday the Supreme Court ruled
 in favor of oil and gas companies, saying they should get another chance to move a climate lawsuit from the city of
 Baltimore out of state court.

The first months of the Biden Administration have shown promise for the revitalization of the alliance between the US and the Republic of Korea (ROK). On Friday, May 21, South Korean President Moon Jae-in will visit Washington as the second world leader to be hosted by the Biden White House, following Japanese Prime Minister Suga's visit last month. Other signs of the importance the new administration places on the US relationship with South Korea include quickly settling a military burdensharing disagreement that had troubled bilateral relations under the Trump Administration, and sending both Secretary of State Antony Blinken and Secretary of Defense Lloyd Austin to Seoul for the officials' first travel overseas. However, to enhance effective cooperate on regional issues, the two countries will need to wade into thornier areas, including relations with China, bridging South Korea-Japan tensions, and addressing threats from North Korea.

After an almost two-year dispute under the Trump Administration, the Biden Administration reached a new six-year cost-sharing deal with Seoul in early March that increases South Korea's financial support of the US military presence it hosts. The Special Measures Agreement (SMA) was a relatively quiet development in contrast to years of highly publicized criticism from Trump and the expiration of the previous SMA in 2019. The Biden campaign team has likened the Trump Administration's SMA grievances and negotiating tactics to extortion, and the current president is clearly aiming to move on to broader strategic issues.

Though the quick resolution of SMA negotiations is an important positive step towards stronger ties with Seoul, it can also be seen as relatively low-hanging fruit when it comes to deepening bilateral relations. While the Moon Administration has welcomed the Biden Administration's re-engagement with multilateralism, Washington and Seoul are not always on the same page when it comes to handling key geopolitical issues like China and North Korea. The Biden Administration's "pivot" to Asia and emphasis on East Asian alliances comes in the context of reframing China as America's primary geopolitical challenge. Seoul, however, wants to avoid





antagonizing China even while it strengthens ties with the US – a concern shared by many US partners, particularly in Asia.

South Korea has ample recent experience with the costs of upsetting Beijing, most notably the severe backlash for Seoul's 2017 deployment of a US THAAD anti-missile system that Beijing saw as a potential threat to its own security. The economic fallout of that decision, which came in forms from consumer boycotts of South Korean products to South Korean TV shows disappearing from Chinese channels, was estimated to cost South Korea over \$7.5 billion in 2017 alone and continues to impact economic ties today. President Moon's administration has endeavored to avoid framing ties with the US as anti-China, with official rhetoric often emphasizing the "broad" nature of US-ROK relations.

This hesitancy for Korea to upset China stands in contrast to rhetoric from joint US-Japan statements, which are more likely to address controversial issue areas like Hong Kong or Xinjiang. The tendency to group together Japan and South Korea as the two key US allies in East Asia forces consideration of another issue: the deterioration of relations between Seoul and Tokyo, which the Biden Administration's

national security team have pledged to help improve. While the two neighbors share many contemporary security and strategic interests, bilateral ties have long been frayed by a series of historical grievances and diplomatic slights - and have worsened in the last three years. Along with its reluctance to be seen as anti-China, acrimony between South Korea and Japan hinders Seoul's engagement in multilateral efforts pushed by the Biden Administration, such as Quad initiatives. Some early signs point to progress in the Biden Administration's efforts: on the sidelines of the G7 ministerial meeting in London earlier this month, US Secretary of State Blinken held a joint meeting with South Korea's Foreign Minister Chung and Japan's Foreign Minister Motegi – the first meeting of the countries' foreign ministers in over a year. As deputy secretary of state during the Obama Administration, Blinken played a role in diplomatic efforts to strengthen Japan-ROK relations, making him a likely figure to drive efforts under Biden.

Along with seeking to improve relations with Japan, the Biden Administration is engaged with Seoul to work jointly on deepening relations with a number of other countries across Asia. Though



concrete policy initiatives have yet to develop, the two countries have begun dialogue on engagement with Southeast Asia in what the State Department described as a "US-ROK dialogue series" on the US vision for the Indo-Pacific and the Republic of Korea's New Southern Policy (a Moon Administration objective for deepening ties with Southeast Asian nations). Last week, the two countries held virtual talks on how both nations could work together with ASEAN, including mention of joint infrastructure projects and cooperation on COVID-19 aid.

South Korea's neighbor to the north is, of course, a top priority for both Washington and Seoul. So far in President Biden's term, Pyongyang has been relatively guiet, allowing the Biden Administration's foreign policy attention to focus on crises elsewhere. The new administration's chief North Korea policy move came in the form of a recently completed policy review, the results of which were outlined in very general terms, such as pledging a "calibrated, practical, and measured approach." The review reaffirmed the "ultimate goal of denuclearization" but contains vague language on plans to get there, saying the US would "offer relief for

particular steps." Though the administration has been reluctant to specifically describe its plan as incremental or step-by-step, it is being broadly framed as something of a middle road between the Trump Administration's pursuit of a grand bargain trading total sanctions relief for total denuclearization and the Obama Administration's approach of withholding engagement until North Korea shifted its behavior.

The ambiguity of the Biden Administration's North Korea strategy will allow for flexibility in the case of developments on the Korean Peninsula and provides room to evolve as consultations continue with South Korea and Japan. It also may keep North Korea policy out of the domestic political eye by failing to produce concrete targets for political opponents or US media to criticize. While the upcoming visit of President Moon could prompt more clarity from the Biden Administration on its North Korea strategy, the two allies must work out differences in their views on how to best deal with Pyongyang. President Moon will leave office in 2022 (South Korea only allows presidents one five-year term), creating pressure to deliver accomplishments within the next year. Critics of President



Moon's approach to North Korea, particularly more hawkish US voices, say he is too willing to give concessions to North Korea in order to achieve a return to dialogue. Moreover, China's important relationship with North Korea could serve as another obstacle to US-South Korea alignment on the issue – though China shares the US' interest in North Korea's denuclearization.


President Moon welcomed the election of President Biden warmly, tweeting that "America is back" following his inauguration. In its first few months, the Biden Administration has emphasized South Korea as one of the most important US allies, giving a strong start to revitalizing relations. However, much of Biden's strong start is seen in relation to a low bar set by President Trump; from the pivot in rhetoric to the new SMA agreement, the Biden Administration's key actions have largely been walking back some of the Trump Administration's more damaging actions. The next steps to level up bilateral relations will be more difficult.



Coronavirus Condition Updates


As of 2100 hours US EDT on May 17, 2021






